APPLICATION FOR ACCREDITATION TO OFFER A QUALIFICATION ON THE GENERAL AND FURTHER EDUCATION AND TRAINING SUB-FRAMEWORK OF QUALIFICATIONS

1. Thank you for your application for accreditation to offer the following subjects of the NATED N1 - N3 Engineering Studies programme:


2. Accreditation attests to the capacity of a private college to offer a qualification on the General and Further Education and Training Qualifications Sub-Framework (GFETQSF), at the required standard.
3. Having carefully considered your application for accreditation, Umalusi Council herewith grants **Crane International Academy of HiTech House Office No. 8, 23 Rhodes Avenue Cnr Botha Street, Witbank, 1034**, provisional accreditation for a period of **two years**, to offer the NATED N1 – N3 Engineering Studies programme. The accreditation period commences on **15 August 2019** and terminates on **31 December 2021**. Accreditation number: **19 FET02 00175 PA**.

4. The decision of Council was informed by the following:
 - 4.1 Legislation and policy:
 - 4.1.1 *The National Qualifications Framework Act, 2008*: The Act provides for the establishment of Umalusi as a Quality Council (QC) for General and Further Education and Training.
 - 4.1.2 *The General and Further Education and Training Quality Assurance (GENFETQA) Act, 2001 amended 2008*: This is the founding Act of Umalusi that outlines Umalusi's specific mandate.
 - 4.1.3 *Policy for the Quality Assurance of Private Colleges for Continuing Education and Training, offering Qualifications registered on the General and Further Education and Training Qualifications Sub-framework, and the Accreditation of Private Assessment Bodies. (Government Gazette 41887 notice 926 of 7 September 2018)*
 - 4.1.4 *Guidelines for Implementation of the Policy and Criteria for Private Colleges in the General and Further Education and Training Qualifications Sub-framework (2018).*
 - 4.2 Reports:
 - 4.2.1 The provider's self-evaluation report;
 - 4.2.2 The desktop evaluation of the self-evaluation report;
 - 4.2.3 The verification site-visit report.
5. The attached "Feedback on Accreditation Application" indicates the areas which must be attended to before the expiry of the accreditation period.
6. The provisional accreditation of **Crane International Academy** is subject to the following conditions:
 - 6.1 For the duration of the provisional accreditation period, the institution must continue to offer the NATED N1 – N3 Engineering Studies programme.
 - 6.2 Further, the institution must provide Umalusi with evidence of compliance with areas of non-compliance as identified in the attached list by **31 July 2020**. Upon receipt of the required evidence and payment of the required fee by this date, Umalusi will re-evaluate the institution's compliance with the accreditation criteria.
 - 6.3 The 2 year provisional accreditation will be withdrawn with immediate effect if the institution is implicated in serious assessment and examination irregularities/malpractices.
7. Umalusi may conduct a special / additional site visit in the event of the following:
 - 7.1 To verify additional evidence provided to support the college's compliance with the accreditation criteria.
 - 7.2 A valid complaint by the learner/s, parent/s, or official/s from the Department of Higher Education and Training and or the public.
 - 7.3 A significant drop in the learner performance of the institution.

- 7.4 A change in the ownership of the institution.
 - 7.5 Any significant change in the institution's staff establishment.
 - 7.6 An application for extension of scope to offer an additional qualification/s or alternate curriculum.
 - 7.7 Failure to comply with health and safety standards, as per the Occupational Health and Safety Act.
8. Should the institution move to new premises and facilities or change ownership, it is required to
- 8.1 notify Umalusi with immediate effect, and
 - 8.2 submit a new application for accreditation.
9. The GENFETQA Act No. 58 of 2001 as amended in 2008, requires private institutions offering qualifications registered on the General and Further Education and Training Qualifications Sub-framework to be accredited by Umalusi. It also requires Umalusi to report accreditation decisions to the Registrar in the Department of Higher Education and Training. At the expiry of the 2 year provisional accreditation period Umalusi will report the final outcome to the Department of Higher Education and Training. Your institution is therefore urged to submit evidence to show compliance with the areas needing attention within the specified timelines.
10. **Marketing**
On receipt of this letter the institution may publicly promote its provisional accreditation status. However, the institution is restricted to the following wording:
- "Provisionally accredited by Umalusi, Council of Quality Assurance in General and Further Education and Training – Accreditation number: 19 FET02 00176 PA."*
